- 1. In the 2022/23 fiscal year, Debre Markos University with fund financed by "Kempten Our School in Ethiopia V", Germany, is going to build a Primary school. Thus, the University invites eligible Contractors of Category GC-6 or BC-5 and above who would be financially and technically capable to the necessary labor, equipment and materials to undertake G+0 First Phase Building Construction Work "Echege Gelila-Kempten Primary School" which consists of Class Rooms, Administration & Library and Toilet in East Gojjam Zone, Sede Woreda, Sereke Berehan Kebele.
- 2. Interested bidder should submit:
 - a) Certificate of registration from relevant Ministry renewed for 2015 EFY with category of GC-6 or BC-5 and above and other appropriate documentary evidences demonstrating the bidder's compliance, which shall include:

Contractors who meet the requirements listed above can purchase the tender document by paying a non-refundable fee of 300.00 ETB (three hundred ETB) from the date of the publication of the tender notice in the Ethiopian Herald or 'Addis Zemen' newspapers during working hours from Debre Markos University Administration Building No. 27, Office No. 10 or Addis Ababa, Arat kilo near to St. Mary's Church Romina Cafe, 1st Floor, Office No. 7.
- 5. The financial original and copy, technical original and copy, tender security, and necessary documents must be submitted separately in an envelope sealed with a secure adhesive.
- 6. Bidders should fill and seal the tender document properly and come to Debre Markos University Administration Building No. 27, Office No. 10, and put it in the box provided until 9:59 AM on the 22nd day after 21 consecutive days from the date of publication of the newspaper. The auction will be closed at 10:00 AM on the same day and will be opened at 10:30 AM in the presence of bidders or their legal representatives in Debre Markos University Administration Building No. 27, Office No. 10. However, if the bidders are unable to attend the auction, as long as they meet the criteria, the auction will be opened on the same day, including the mail of the bidders who did not attend the auction.
- 7. The winning company must appear in person within 7 consecutive working days after the winning company has been announced and make a contract within 5 days by placing a deposit of 10% of the total price of the winning company.
